- 1 WHEREAS, section 104 of title 55 of the Code of the

- 3 requires that Congress adopt a resolution setting forth the
- 4 total funds estimated to be available from the General Fund and
- 5 any special funds estimated of the Treasury of the Federated
- 6 States of Micronesia for each fiscal year; now, therefore,
- 7 BE IT RESOLVED by the Twenty-First Congress of the
- 8 Federated States of Micronesia, Second Regular Session, 2019,
- 9 that the amount estimated to be available for the fiscal year
- 10 ending September 30, 2020, is set at \$64,677,508 of which
- 11 \$62,036,867 is from domestic revenues, \$1,000,000 will be
- 12 available from the Amended Compact sector grant, and \$1,640,641
- 13 will be available from the Supplemental Education Grant; and
