## A BILL FOR AN ACT

To appropriate the sum of \$100,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1982, for the purpose of purchasing emergency food supplies for the outer islands of the State of Truk in need thereof due to past typhoon and other naturally caused damage, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONISIA:

- 1 Section 1. The sum of \$100,000, or so much thereof as
- 2 may be necessary, is hereby appropriated from the General Fund
- 3 of the Federated States of Micronesia for the fiscal year ending
- 4 September 30, 1982, for the purpose of purchasing emergency
- 5 Good supplies for the Truk outer islands in need thereof due to past
- 6 typhoon and other naturally caused damage as determined by
- 7 the Governor of the State of Truk after consultation with and
- 8 due consideration of the recommendations of the Truk Outer
- 9 Islands Task Force. The distribution of the emergency food
- 10 supplies shall be administered by the Governor in consultation
- 11 with the Truk Outer Islands Task Force in a manner calculated
- 12 to ensure an equitable distribution thereof.
- 13 Section 2. The sum herein appropriated shall be used
- 14 solely for the purchase of emergency food supplies in accordance
- 15 with this act and shall not be used for any other purpose,
- 16 such as administration, distribution, and transportation
- 17 expenses.
- Section 3. Whenever reasonably practicable, preference
- 19 shall be given to the purchase of Totally produced food products
- 20 from within the Federated States of Micronesia.
- 21 Section 4. All funds appropriated by this act shall be
- 22 allotted to the Governor of the State of Truk and managed,

administered, and accounted for in accordance with applicable 1 law, including, but not limited to, the Financial Management 2 Act of 1979. The allottee shall be responsible for ensuring 3 that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that no 5 obligations are incurred in excess of the sum appropriated. 6 The authority of the allottee to obligate funds appropriated 7 by this act shall lapse as of September 30, 1982. 8 Section 5.
