A BILL FOR AN ACT

To amend 52 TTC 2, as set forth by Public Law No. 7-71, and as amended by Public Law No. 1-34, Public Law No. 1-91, and Public Law No. 1-104, relating to approval of foreign fishing agreements by committees of Congress if the Congress is not in session, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 2 of 52 TTC (Public Law No. 7-71), as
2	amended by Public Law No. IC-3 and Public Law No. 1-34, is hereby
3	further amended to read as follows:
4	"Section 2. <u>Definitions</u> . As used in this Title, unless
5	the context otherwise requires, the term:
6	(1) "Atoll" means a circular or oval coral reef
7	forming a geographic and ecologic unity crowned by at
8	least one island.
9	(2) "Authority" means the Micronesian Maritime
10	Authority established by Section 101 of this Title.
11	(3) "Congress" means the Congress of the Federated
12	States of Micronesia.
13	(4) "Executive Director" means the Executive
14	Director of the Micronesian Maritime Authority.
15	(5) "State" means any of the States of the Federated
16	States of Micronesia.
17	(6) "Fish" means any living resource.
18	(7) "Fishery" means:
19	(a) One or more stocks of fish which can be
20	treated as a unit for purposes of conservation and
21	management and which are identified on the basis of
22	geographical, scientific, technical, recreational, and
23	economic characteristics; and
24	(b) Any fishing for such stock.

(8) "Fishing" means:

1	(a) The actual or attempted catching, taking or
2	harvesting of fish;
3	(b) Any other activity which can reasonably be
4	expected to result in the catching, taking or harvesting
5	of fish; or
6	(c) Any operations at sea in support of or in
7	preparation for, any activity described in paragraphs (a)
8	and (b) above.
9	- (9) "Fishing Vessel" means any vessel, boat, ship,
1:0	or other craft which is used for, equipped to be used for,
11	or of a type that is normally used for:
12	(a) Fishing,
13	(b) Aiding or assisting one or more vessels at sea
14	in the performance of any activity related to fishing,
15	including but not limited to, preparation, supply, storage,
16	refrigeration, transportation, or processing.
17	(10) "Foreign Fishing Agreement" means an agreement
18	between the Authority on behalf of the Government of the
19	Federated States of Micronesia and one or more foreign
20	commercial fishing interests to permit foreign vessels to
21	harvest fish within the Extended Fishery Zone of the
22	Federated States of Micronesia. A 'foreign party' is a
23	party to such an agreement other than the Authority. To
24	take effect within the Extended Fishery Zone of the Federated
25	States of Micronesia, such agreement shall require the

1	approval of the Congress of the Federated States of
2	Micronesia by resolution; PROVIDED, that such an agree-
3	ment involving fewer than six vessels will not require the
4	approval of the Congress of the Federated States of
5	Micronesia; and PROVIDED, FURTHER, that the Committee on
6	Resources and Development and the Committee on External
7	Affairs of the Congress of the Federated States of
8	Micronesia shall jointly approve such an agreement if the
9	Congress is not in session.
10	(11) "Foreign fishing" means fishing by vessels:
11	(a) Not registered in Micronesia, or
12	(b) Not wholly owned by citizens of Micronesia, or
13	(c) Not wholly controlled by citizens of
14	Micronesia, or
15	(d) Of foreign registry chartered by citizens of
16	Micronesia.
17	(12) "Island" means a naturally formed area of land,
18	surrounded by water, which is above water at high tide.
19	(13) "Living resource" means finfish, mollusks,
20	crustaceans, and all other forms of marine animal and plant
21	life other than marine birds.
22	(14) "Micronesia" or "Government of Micronesia" refers
23	to the appropriate State Government, or the Government of
24	the Federated States of Micronesia.
. 25	(15) "Person" means any individual, corporation,

partnership, association, or other entity, the Government
of Micronesia or any of its subdivisions or any entity
thereof, and any foreign government, subdivision of such
government or entity thereof.
(16) "Reef fish" means any species of living
resource which predominately inhabits reef areas or
internal waters.
(17) "Stock of fish" means a species, subspecies,
geographical grouping, or other category of fish capable
of management as a unit.
(18) "Submerged reef" means a coral reef forming a
geographic and ecologic unity which is wholly submerged at
high tide."
Section 2. This act shall become law upon approval by the
President of the Federated States of Micronesia or upon its becoming
law without such approval.
