## A BILL FOR AN ACT

To amend Public Law No. 2-21, as amended by Public Law No. 2-26, to add a new section 8 thereto; to appropriate the sum of \$1,011,468 from the United States Grant Special Fund for the management and administration of United States Federal programs in the Federated States of Micronesia; and for other purposes.
