

## SECOND CONGRESS OF THE FEDERATED STATES OF MICRONESIA

THIRD REGULAR SESSION, 1982

CONGRESSIONAL BILL NO. 2-253, C.D.1

## AN ACT

To further amend sections 1 and 2 of Public Law No. 1-142, as amended by Public Law No. 2-2, relating to an appropriation to fund certain public projects in the State of Truk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 1 of Public Law No. 1-142, as amended by Public Law No. 2-2, is hereby further amended to read as follows:

"Section 1. The sum of \$636,300, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1981, for the purpose of funding certain public projects in the State of Truk. The sum appropriated shall be apportioned in the following manner:

20 Section 2. Section 2 of Public Law No. 1-142, as amended by

21 Public Law No. 2-2, is hereby further amended to read as follows:

22 "Section 2. All funds appropriated by this act shall be  
 23 allotted, managed, administered and accounted for in  
 24 accordance with applicable law, including, but not limited to,  
 25 the Financial Management Act of 1979. The allottee shall be

1 responsible for ensuring that these funds, or so much there-  
2 of as may be necessary, are used solely for the purposes  
3 specified in this act, and that no obligations are incurred  
4 in excess of the sum appropriated. The funds apportioned by  
5 paragraphs (g), (h), (i), (j) of Subsection (5) and Para-  
6 graph (e) of Subsection 6 shall not be obligated until the  
7 relevant municipal government has submitted a document identi-  
8 fying specific projects and the amounts required therefor, such  
9 document reflecting the determinations of the chief magistrate  
10 and municipal council of the relevant municipality as indicated  
11 by the signature of the chief magistrate. The authority of the  
12 allottee to obligate funds appropriated by this act shall lapse  
13 as of September 30, 1984."

14 Section 3. This act shall become law upon approval by the President  
15 of the Federated States of Micronesia or upon its becoming law without  
16 such approval.
