A BILL FOR AN ACT

To amend title 22 of the Cole of the Federated States of Micronesia by amending section 202 for the purpose of repealing subsection (4) relating to prices paid to producers of coconut products, and for other purposes.

- BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: Section 1. Section 202 of title 22 of the Code of the Federated 1 States of Micronesia is hereby amended to read as follows: "Section 202. 8	securities of every description including mortgages, bonds,
9	debentures, promissory notes, commercial paper, and securities
10	of other classes;
11	(98) determine the character of and the necessity for
12	its obligations and expenditures and the manner in which
13	they shall be incurred, allowed, and paid;
14	(109) promulgate regulations, not inconsistent with
15	this chapter, necessary or appropriate for the conduct of
16	the affairs of the Authority;
17	(1110) appoint such managers, officers, attorneys,
18	agents, and employees, as the Authority may determine, and
19	require bonds for the faithful performance of their duties
20	and to pay the premium for such bonds;
21	(1711) execute all instruments necessary or appropriate
22	in the exercise of any of its powers; and
23	(1312) take such other actions as may be necessary or
24	appropriate to carry out the powers herein or hereafter
25	specifically conferred upon it."
