

AN ACT

To further amend section 1 of Public Law No. 2-34, as amended by Public Law No. 2-44, appropriating the sum of \$846,200 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1982, for the purpose of funding certain public projects in the State of Truk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 2-34, as amended by  
2 Public Law No. 2-44, is hereby further amended to read as follows:

3 "Section 1. The sum of \$846,200, or so much thereof as  
4 may be necessary, is hereby appropriated from the General  
5 Fund of the Federated States of Micronesia for the fiscal  
6 year ending September 30, 1982, for the purpose of funding  
7 certain public projects in the State of Truk. The sum  
8 appropriated by this section shall be apportioned as follows:
