## A RESOLUTION

- WHEREAS, the Micronesian Maritime Authority, Palau Maritime Authority, 1
- Government of the Republic of Kiribati, and the American Tunaboat Association
- concluded a fisheries access agreement on February 24, 1983; and 3
- WHEREAS, the Federated States of Micronesia Congressional Committee on
- Resources and Development has approved said fisheries access agreement in
- accordance with 24 F.S.M.C. 406(2); and
- WHEREAS, the Governments of the Federated States of Micronesia, Republic 7
- of Kiribati, and the Republic of Palau, on February 24, 1983, entered into an
- international agreement entitled "An Agreement Among Coastal States Regarding
- A Fishery Access Agreement With The American Tunaboat Association " the 10
- purpose of which is to administer said fisheries access agreement; and 11
- WHEREAS, it is required by article IX, section 4, of the Constitution of 12
- the Federated States of Micronesia that said international agreement be 13
- ratified by the Congress; and 14
- WHEREAS, said international agreement will benefit the Federated States 15
- of Micronesia by facilitating the generation of fisheries revenue and by 16
- promoting the efficient management of the tuna resource in the Extended 17
- Fishery Zone of the Federated States of Micronesia; now therefore,
- BE IT RESOLVED by the Third Congress of the Federated States of 19
- Micronesia, First Regular Session, 1983, that the Congress ratifies the 20
- international fishery agreement entitled "An Agreement Among Coastal States
- Regarding A Fisheries Access Agreement With The American Tunaboat 22
- 23 Association" entered into on February 24, 1983, by the Governments of the
- Federated States of Micronesia, Republic of Kiribati, Republic of Palau, and 24
- 25 the American Tunaboat Association; and
