A RESOLUTION

Requesting the President of the Federated States of Micronesia to initiate discussions with appropriate officials from the Republic of China and its fishing industry in order to eliminate the frequent recurrence of illegal fishing activities in Federated States of Micronesia waters by vessels of the Republic of China fishing fleet.

- 1 WHEREAS, during the past 18 months, the government field trip
- 2 vessel servicing Yap State has apprehended four fishing vessels from the
- 3 Republic of China for illegal fishing activities in the Federated States
- 4 of Micronesia Exclusive Economic Zone; and
- 5 WHEREAS, 2 months ago, the surveillance vessel under contract to the
- 6 Federated States of Micronesia apprehended another fishing vessel from the
- 7 Republic of China which was also engaged in illegal fishing activities within
- 8 the waters of the Federated States of Micronesia near Yap State; and
- 9 WHEREAS, the Yap State government has in recent months received
- 10 numerous complaints from residents of the State's outer islands regarding
- 11 foreign purse-seiner and long-liner fishing vessels apparently engaged
- 12 in illegal fishing activities within State waters; and
- 13 WHEREAS, based upon the nationality of those fishing vessels
- 14 apprehended to date, a reasonable inference may be drawn that at least
- 15 some of the other fishing vessels observed but not apprehended could
- 16 also be of Republic of China origin; and
- 17 WHEREAS, most of the illegal Republic of China fishing vessels
- 18 apprehended in the vicinity of Yap State have been dilapidated and
- 19 ill-suited for local use upon conviction of their crews and forfeiture
- 20 of the vessels to the government; now, therefore,
- 21 BE IT RESOLVED by the Third Congress of the Federated States of
- 22 Micronesia, Fourth Regular Session, 1984, that the President of the
- 23 Federated States of Micronesia is hereby requested to initiate
- 24 discussions with appropriate officials from the Republic of China and
- 25 its fishing industry in order to eliminate the frequent recurrence of

1 illegal fishing activities in Federated States of Micronesia waters by vessels of the Republic of China fishing fleet; and BE IT FURTHER RESOLVED that in the event that the elimination of the illegal fishing problem cannot be achieved through discussions with the Republic of China, the President of the Federated States of Micronesia is further requested to urge the Republic of China and its fishing industry to engage in illegal fishing within Federated States of Micronesia waters only with modern, well-equipped, and well-maintained fishing vessels that can be used proudly and safely by Federated States of Micronesia citizens upon the conviction of the vessels' crews and 10 the forfeiture of the vessels to the government; and 11 BE IT FURTHER RESOLVED that certified copies of this resolution be 12 transmitted to the President of the Federated States of Micronesia, the 13 Secretary of the Department of External Affairs, and the executive 14 15 director of the Micronesian Maritime Authority. / 16 Introduced by: Date: 10/12/84 17 Isaac V.
