A BILL FOR AN ACT

To further amend section 6 of Public Law No. 3-48, as amended by Public Law No. 3-69, for the purpose of appropriating the sum of \$150,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1985, as supplemental funding for the Student Loan Revolving Fund, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 6 of Public Law No. 3-48, as amended by Public
2	Law No. 3-69, is hereby further amended to read as follows:
3	"Section 6. Other National Government programs, grants,
4	subsidies, contributions, and refunds. The sum of \$1/242/000
5	1,392,000, or so much thereof as may be necessary, is hereby
6	appropriated from the General Fund of the Federated States of
7	Micronesia for the fiscal year ending September 30, 1985, for
8	special programs, grants, subsidies, contributions, and
9	refunds of the National Government of the Federated States
10	of Micronesia during fiscal year 1985. The sums appropriated
11	by this section shall be apportioned as follows:
