## A BILL FOR AN ACT

To further amend sections 301 and 305 of title 24 of the Code of the Federated States of Micronesia, as amended by Public Law No. 3-10, to change the size and composition of the Micronesian Maritime Authority, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- Section 1. Section 301 of title 24 of the Code of the Federated

## "Section 301. Micronesian Maritime Authority-Established.

- (1) There is hereby established a Micronesian Maritime the Congress of the Federated States of Micronesia appointed by the Speaker of the Congress of the Federated States of Micronesial. one attlated hembet appointed by the Ptesident of the rederated states of Micronesia in consultation with the Speakers and the temaining two members being the secretary of External Affairs, or his designed, and the secretary of Resources and Developments of Wis designees provided Novevers that offerent members of the Authority shall serve until their tetus of appointment expitel
  - (2) All appointments shall be for a term of two years. The term of office of each original member shall commence effective the date of the first meeting of the Authority. Vacancies shall be filled in the same manner as the original appointment for the remainder of the term of office of the vacancy.
  - (3) The chairman shall be chosen by the majority vote of the members of the Authority. The Authority shall meet at such times and places as may be designated by the chairman or by the Authority. The Authority shall adopt its own rules of
