A BILL FOR AN ACT

To amend Public Law No. 4-11 by amending sections 1, 2, and 7 for the purpose of appropriating the sum of \$102,068 from the General Fund of the Federated States of Micronesia and the sum of \$11,500 from the United States Grant Special Fund for the fiscal year ending September 30, 1986, as supplemental funding for the operations of the executive branch and legislative branch during fiscal year 1986; to establish employment ceilings; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
