## A BILL FOR AN ACT

To appropriate the sum of \$1,000,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1986, for the purpose of funding public projects in the State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

The allottee shall be the Governor of Pohnpei State for all the appropriations herein, except for appropriations under subsections (1), of section 1 which shall be the Pohnpei Community Action Agency. The 5 allottees shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purposes specified in this act, and that no obligations are incurred in excess of the sum appropriated. The authority of the allottees to obligate funds appropriated by this act shall lapse as of September 30, 1986. Section 4. This act shall become law upon approval by the 10 President of the Federated States of Micronesia or upon its becoming 11 12 law without such approval. Date: 10. 5,1985 Introduced by: Peter M.
