A BILL FOR AN ACT

To appropriate and authorize funds for the economic development of Faichuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Statement of purpose. The people of the Faichuk
- 2 island group of Truk State have long been frustrated in their pursuit
- of economic development and modern progress. The Faichuk area with
- 4 its central population cluster is crucial to the progress of Truk
- 5 State, yet because of political and economic circumstances outside
- 6 the control of the Faichuk people, the area's history has been marred
- 7 with economic stagnation and thwarted progress. The Faichukese have
- 8 seen the modern era flourish about them, yet felt forsaken; have
- 9 striven for advancement, yet realized only a dream deferred. Aid is
- 10 long overdue, and by this act the Government intends to boost the
- 11 progress and enhance the development of the Faichuk area by
- 12 appropriating the sums needed for the purposes specified to spur the
- 13 advance to the modern era and help to turn the dream deferred to a
- 14 success achieved.
- Section 2. Appropriation Dispensary. The sum of \$200,000, or
- 16 so much thereof as may be necessary, is hereby appropriated from the
- 17 General Fund of the Federated States of Micronesia for the fiscal year
- 18 ending September 30, 1987, for the construction and operation of a
- 19 medical dispensary in Tol Municipality and for the housing of visiting
- 20 physicians who may be recruited to staff the dispensary.
- 21 Section 3. Appropriation and authorization Road construction.
- 22 (1) The sum of \$200,000, or so much thereof as may be
- 23 necessary, is hereby appropriated from the General Fund of the
- 24 Federated States of Micronesia for the fiscal year ending September
- 25 30, 1987, for the construction and maintenance of a road connecting

1 the municipalities of Tol, Wonei, and Polle and for a road connecting the municipalities of Wonei and Patta. (2) The sum of \$200,000, or so much thereof as may be 3 necessary, is hereby authorized to be appropriated from the General Fund of the Federated States of Micronesia for each of the fiscal years 1988 through 1991 to be made available for the purposes specified in subsection (1) of this section. 7 Section 4. Accountability of funds. All funds appropriated by this act shall be allotted, managed, administered, and accounted for in accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. The allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, 13 are used solely for the purposes specified in this act, and that no obligations are incurred in excess of the sums appropriated. The authority of the allottee to obligate funds appropriated by this act 16 shall lapse as of September 30, 1987. Section 5. Effective date. This act shall become law upon 17 approval by the President of the Federated States of Micronesia or 18 upon its becoming law without such approval. 19 20 Date: 8-29-86 Introduced by: 21 John R.
