1	Section 2. Section 4 of Public Law No. 4-23, as amended by Pub

3	"Section 4. All funds appropriated by this act shall be		
4	allotted, managed, administered, and accounted for in		
5	accordance with applicable law, including, but not limited		
6	to, the Financial Management Act of 1979. The allottee for		
7	the funds apportioned under subsections (1), (2), (3), (4),		
8	(5), (6), (7), (8), (9), (10), (11), (12), (AB) (14) and		
9	(15)/ #44 (146) of section 2 of this act shall be the		
10	Governor of Yap State. The allottee for the funds		
11	apportioned under subsection ( $\frac{14}{2}$ 13) of section 2 of this		
12	act shall be the chairman of the Yap congressional		
13	delegation. The allottees shall be responsible for		
14	ensuring that these funds, or so much thereof as may be		
15	necessary, are used solely for the purposes specified in
