CONGRESSIONAL BILL No. 4-220, C.D.1

AN ACT

To amend sections 2 and 3 of Public Law No. 4-28, Truk State public projects, for the purpose of reapportioning funds and designating an additional allottee, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 4-28 is hereby amended
2 to read as follows:

2 "Section 3. All funds appropriated by this act shall be
3 allotted, managed, administered, and accounted for in
4 accordance with applicable law, including, but not limited
5 to, the Financial Management Act of 1979. The allottee of
6 funds appropriated under subsection (1)(i) of section 2
7 shall be the Truk Lagoon radio association. The allottee
8 of funds appropriated under subsection (1)(j) of section 2
9 shall be the chairman of the Truk congressional delegation.
10 The allottee of funds appropriated under subsections
11 (9)(b), (9)(c), and (9)(d) of section 2 shall be the
12 Governor of Truk State. The other allottees shall be the
13 development authorities for the respective areas of Truk
14 State. The allottees shall be responsible for ensuring
15 that these funds, or so much thereof as may be necessary,
16 are used solely for the purposes specified in this act, and
17 that no obligations are incurred in excess of the sum
18 appropriated. The authority of the allottees to obligate
19 funds appropriated by this act shall remain effective until
20 funds are fully expended. The allottees shall make a
21 written report of the status of the funds appropriated
22 hereunder to the Congress of the Federated States of
23 Micronesia during its October regular session each year
24 until such time as all funds are fully expended."


