#### AN ACT

To appropriate the sum of \$6,637,488 from the General Fund of the Federated States of Micronesia and the sum of \$5,759,889 from the United States Grant Special Fund for the fiscal year ending September 30, 1987, for the operations of the executive branch, legislative branch, National judiciary, Public Auditor, agencies of the National Government, and for special programs, contributions, grants, subsidies, and refunds of the National Government during fiscal year 1987; to establish employment ceilings; and for other purposes.

Reprogramming. 3 (1) The President or his designee may reprogram up to 10 4 percent to and from the funds appropriated to each of the subsections 5 in section 1, and may reprogram up to 15 percent to and from the funds 6 appropriated in each of the paragraphs within the subsections of section 1. 7 (2) The Speaker or his designee may reprogram up to 10 8 percent to and from the funds appropriated to each of the subsections 9 in section 2, and may reprogram up to 15 percent to and from the funds appropriated in each of the paragraphs within the subsections of section 2. 10 11 (3) The Chief Justice or his designee may reprogram up 12 to 15 percent to and from the funds appropriated in each of the sub-13 sections in section 3. Change in Fund structure. If prior to the lapsing of the appropriations under this act, the United States Grant Special Fund 20 21 is abolished and all moneys then in the Fund are transferred to the 22 General Fund, then the appropriations made in this act from the United 23 States Grant Special Fund shall be deemed to be made from the General 24 Fund as successor to the United States Grant Special Fund. Section 10. Allotment and management of funds and lapse date. 25

1	All funds appropriated by this act shall be allotted, managed,
2	administered, and accounted for in accordance with applicable law,
3	including, but not limited to, the Financial Management Act of 1979,
4	as amended. Each allottee shall be responsible for ensuring that
5	these funds, or so much thereof as may be necessary, are used solely
6	for the purposes specified in this act, and that no obligations are
7	incurred in excess of the sum appropriated. No funds provided by
8	subsections (8) and (9) of section 6 of this act may be obligated
9	until the National Government obtains either title to the land on
10	which the buildings are to be constructed or a leasehold interest to
11	the land on which the buildings are to be constructed of a duration
12	equal to the useful life of the buildings. The authority of the
13	allottees to obligate funds appropriated by this act shall lapse as
14	of September 30, 1987.
15	Section 11. Effective date. This act shall become law upon
16	approval by the President of the Federated States of Micronesia or
17	upon its becoming law without such approval.
