A BILL FOR AN ACT

To propose an amendment to article IX, sections 2 and 3 of the Constitution of the Federated States of Micronesia to permit States to levy taxes, duties, and tariffs based on imports, and for other purposes.

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. It is hereby proposed that article IX, section 2,
2	of the Constitution of the Federated States of Micronesia be amended
3	to read as follows:
4	"Section 2. The following powers are expressly delegated
5	to Congress:
6	(a) to provide for the national defense;
7	(b) to ratify treaties;
8	(c) to regulate immigration, emigration,
9	naturalization, and citizenship;

14	Section 2. It is hereby proposed that article IX, section 3, of
15	the Constitution of the Federated States of Micronesia be amended
16	to read as follows:
17	"Section 3. The following powers may be exercised con-
18	currently by Congress and the states:
19	(a) to appropriate public funds;
20	(b) to borrow money on the public credit;
21	(c) to promote education and health; and
22	(d) to establish systems of social security and
23	public welfare/; and
24	(e) to impose taxes, duties, and tariffs on
25	imports."

1	Section 3. Upon this act becoming law, the proposed constitu-
2	tional amendments set out in sections 1 and 2 of this act will become
3	part of the Constitution after completion of procedures and ratifica-
4	tion as required by Public Law No. 2-51, as amended by Public Law
5	No. 2-58, and as codified in chapter 7 of title 1 of the Code of the
6	Federated States of Micronesia.
7	Section 4. This act shall become law upon approval by the
8	President of the Federated States of Micronesia or upon its becoming
9	law without such approval.
