A BILL FOR AN ACT

To amend title 50 of the Code of the Federated States of Micronesia, as amended by Public Law No. 5-54, by adding a new chapter 3 requiring health certificates and physical examinations of entry permit holders; by repealing sections 201 through 207 of title 51 of the Code of the Federated States of Micronesia; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Title 50 of the Code of the Federated States of
2	Micronesia is hereby further amended by adding a new section 301 of
3	chapter 3 to read as follows:
4	"Section 301. Statement of Policy.
5	(1) It is the policy of the Federated States of
6	Micronesia to insure the health of its citizens, and to
7	prevent the overtaxation of its medical and hospital
8	facilities and personnel in the care and treatment of
9	noncitizens who arrive in the Federated States of Micro-
10	nesia in a condition of ill health.
11	(2) To this end, it shall be the practice of the
12	Federated States of Micronesia, in accordance with the
13	terms of this chapter:
14	(a) To require each person entering the country
15	for more than 30 days to have in his possession a
16	certificate of freedom from contagious disease;
17	(b) To conduct examinations of every person
18	entering the country from a country with a high incidence
19	of contagious diseases for the existence of such diseases;
20	and
21	(c) To revoke the entry permit of anyone who
22	entered the country with a falsified health certificate or
23	carrying a contagious disease."
24	Section 2. Title 50 of the Code of the Federated States of
25	Migraposia is hereby further amended by adding a new section 302 of

2		"Section 302. Health Certificates. Every p	erson required
3		to have an entry permit to enter the Federat	ed States of
4		Micronesia by section 102 of this title shall	1 have in his
5		possession, and thereafter shall keep in his	possession, a
6		certificate of freedom from communicable dis	eases,
7		including but not limited to the immunizable	diseases,
8		sexually transmitted diseases, acquire immun	e deficiency
9		syndrome, tuberculosis, Hanson's disease and	cholera. Such
10		certificate shall be executed and validated	not more than
11		30 days preceding the date of first entry of	such person
12		into the Federated States of Micronesia by a	physician
13		licensed to practice medicine in the country	of origin of
14		that person. No certificate shall be requir	ed of a person
15		renewing an entry permit."	
16	Sect	ion 3. Title 50 of the Code of the Federated	States of
17	Micronesi	a is hereby further amended by adding a new	ection 303 of
18	chapter 3	to read as follows:	
19		"Section 303. Physical examination. Within	15 days after
20		his initial entry into the Federated States	of Micronesia,
21		each holder of an entry permit from a country	y with a high
22		incidence of any communicable disease shall	be subject to
23		an examination to determine whether the perm	nit holder has
24		contracted the specified communicable disease	se. The
25		Secretary of the Department of Human Resour	ces shall be

1	responsible for maintaining a list of countries with a
2	high incidence of communicable diseases and the specific
3	diseases for which each permit holder from such country
4	is to be tested. The cost of such examination shall be
5	borne by the permit holder."
6	Section 4. Title 50 of the Code of the Federated States of
7	Micronesia is hereby further amended by adding a new section 304
8	of chapter 3 to read as follows:
9	"Section 304. Revocation of entry permit.
10	(1) The entry permit shall be revoked of any person:
11	(a) Found to have a communicable disease as a
12	result of an examination performed pursuant to section 303
13	of this chapter; or
14	(b) Found to hold a falsified health certificate.
15	(2) The entry permits of any persons whose permits
16	were based on the issuance of an entry permit to a person
17	whose entry permit is revoked pursuant to subsection (1) of
18	this section shall be revoked."
19	Section 5. Title 50 of the Code of the Federated States of
20	Micronesia is hereby further amended by adding a new section 305 of
21	chapter 3 to read as follows:
22	"Section 305. Regulations. The Secretary of the Depart-
23	ment of Human Resources shall have the power to establish
24	and promulgate regulations pursuant to this chapter."
25	Section 6. Sections 201 through 207 of title 51 of the Code of

1	the Federated States of Micronesia are hereby repealed in their
2	entirety.
3	Section 7. This act shall become law upon approval by the
4	President of the Federated States of Micronesia or upon its becoming
5	law without such approval.
