

## AN ACT

To further amend Public Law No. 5-15, as amended by Public Laws Nos. 5-28 and 5-45, by further amending sections 1, 2, 5, 7, 11 and 16, as amended by Public Laws Nos. 5-28 and 5-45, for the purpose of appropriating the sum of \$1,194,710 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1988, as supplemental funding for the National budget, and from special funds available under Compact section 215(a)(2), and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1       Section 1. Section 1 of Public Law No. 5-15, as amended by Public  
2 Law No. 5-28, is hereby further amended to read as follows:
- 3               "Section 1. Operating expenses of the executive branch.  
4               The sum of \$8,456,261, or so much thereof as may be  
5               necessary, is hereby appropriated from the General Fund  
6               of the Federated States of Micronesia for the fiscal year  
7               ending September 30, 1988, for the operations of the executive  
8               branch of the National Government of the Federated States of  
9               Micronesia during fiscal year 1988. The sum appropriated by  
10              this section shall be apportioned as follows:

10 1988, for the operations of the legislative branch of the  
11 National Government of the Federated States of Micronesia  
12 during fiscal year 1988. The sum appropriated by this section  
13 shall be apportioned as follows:

8 Section 4. Section 7 of Public Law No. 5-15, as amended by Public  
9 Law No. 5-28, is hereby further amended to read as follows:

10 "Section 7. Telecommunications. The sum of \$829,800, or so  
11 much thereof as may be necessary, is hereby appropriated from  
12 the General Fund of the Federated States of Micronesia for the  
13 fiscal year ending September 30, 1988, for the FSM  
14 Telecommunications Corporation during fiscal year 1988.  
15 The funds appropriated under this section shall be deemed to  
16 come: \$751,800 from the funds available under section 215(a)(2)  
17 of the Compact of Free Association, and \$78,000 from the funds  
18 available under section 215(b)(2) of the Compact of Free  
19 Association; this latter sum of \$78,000 is intended as  
20 a supplemental to the funds appropriated by Public Law No. 5-5."

21 Section 5. Section 11 of Public Law No. 5-15, as amended by Public  
22 Law No. 5-28, is hereby further amended to read as follows:

23 "Section 11. Other National Government programs, grants,  
24 subsidies, contributions, and refunds. The sum of \$1,643,259,  
25 or so much thereof as may be necessary, is hereby appropriated

1 from the General Fund of the Federated States of Micronesia for  
2 the fiscal year ending September 30, 1988, for special programs,  
3 grants, subsidies, contributions, and refunds of the National  
4 Government of the Federated States of Micronesia during  
5 fiscal year 1988. The sum appropriated by this section  
6 shall be apportioned as follows:

14 Section 6. Section 16 of Public Law No. 5-15, as amended by  
15 Public Law No. 5-28, is hereby further amended to read as follows:

16 "Section 16. Allotment and management of funds and lapse  
17 date. All funds appropriated by this act shall be allotted,  
18 managed, administered, and accounted for in accordance with  
19 applicable law, including, but not limited to, the Financial  
20 Management Act of 1979, as amended. Each allottee shall be  
21 responsible for ensuring that these funds, or so much thereof  
22 as may be necessary, are used solely for the purposes specified  
23 in this act, and that no obligations are incurred in excess  
24 of the sum appropriated. The authority of the allottees to  
25 obligate funds appropriated by this act shall lapse as of



1 September 30, 1988; PROVIDED, however, that the authority  
2 of the allottees to obligate funds appropriated by subsections  
3 (6), (7), (12) and (13) of section 1 of this act and subsections  
4 (1), (7), (9) and (10) of section 5 of this act shall lapse as  
5 of December 31, 1987; and PROVIDED FURTHER, however, that the  
6 authority of the allottees to obligate funds appropriated by  
7 section 13 of this act shall not lapse."

8 Section 7. This act shall become law upon approval by the  
9 President of the Federated States of Micronesia or upon its becoming law  
10 without such approval.
