A BILL FOR AN ACT

To appropriate the sum of \$1,000,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, for the purpose of construction of primary and secondary roads in each of the States of the Federated States of Micronesia, and for other purposes.

| 11 | (4) Roads in Kosrae State 200,000 |
| 12 | Section 3. All funds appropriated by this act shall be |
| 13 | allotted, managed, administered, and accounted for in accordance with |
| 14 | applicable law, including, but not limited to, the Financial |
| 15 | Management Act of 1979. The allottee of the funds appropriated |
| 16 | under each subsection of section 2 of this act shall be the Governor |
| 17 | of each State for which appropriations are being made. Each allottee |
| 18 | shall be responsible for ensuring that these funds, or so much |
| 19 | thereof as may be necessary, are used solely for the purpose specified |
| 20 | in this act, and that no obligations are incurred in excess of the |
| 21 | sum appropriated. The authority of the allottees to obligate funds |
| 22 | appropriated by this act shall lapse as of September 30, 1990. |
