A BILL FOR AN ACT

To further amend Public Law No. 5-89, as amended, by further amending section 3, as amended by Public Laws Nos. 5-99 and 6-20, for the purpose of modifying the uses of funds appropriated for public projects in Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 5-89, as amended by Public
2 Laws Nos. 5-99 and 6-20, is hereby further amended to read as follows:

3 "Section 3. Southern Namoneas public projects. The sum of
4 \$458,000, or so much thereof as may be necessary, is hereby
5 appropriated from the General Fund of the Federated States
6 of Micronesia for the fiscal year ending September 30, 1989,
7 for the purpose of funding certain public projects in
8 Southern Namoneas, Truk State. The sum appropriated by this
9 section shall be apportioned as follows:
