CONGRESSIONAL BILL NO. 6-101

AN ACT

To further amend Public Law No. 5-67, as amended by Public Laws Nos. 5-111 and 6-6, by further amending sections 2 and 3, as amended by Public Laws Nos. 5-111 and 6-6, for the purposes of allocating funds appropriated therein, modifying the designation of allottees, extending the lapse date, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 5-67, as amended by
2 Public Laws Nos. 5-111 and 6-6, is hereby further amended to read as
3 follows:

"Section 3. All funds appropriated by this act shall be allotted, managed, administered, and accounted for in accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. The allottee of the funds appropriated under sub-paragraphs (a), (b), (c), (d), (e), (f), and (g) of subsection (1) of section 2 of this act shall be the Governor of the State of Pohnpei. The allottee of the funds appropriated under sub-paragraph (h) of subsection (1) of section 2 of this act, and under subparagraphs (d), (e), (f), (g), (h) and (k)(ii) of subsection (2) of section 2 of this act shall be the Pohnpei Community Action Agency. The allottee of the funds appropriated under sub-paragraph (a) of subsection (2) of section 2 of this act shall be the Menin Keder Lapalap of the Madolenihmw Municipal Government, except for those funds

1 appropriated under sub-paragraph (a)(xxxiv) of subsection
2 (2) of section 2 of this act for which the allottee shall
3 be the Menin Keder Lapalap of the Madolenihmw Municipal
4 Government and the Menin Tiensapw of Madolenihmw. The
5 allottee of the funds appropriated under sub-paragraph (b)
6 of subsection (2) of section 2 of this act shall be the
7 Luhken Menlap of the Kitti Municipal Government, except for
8 those funds appropriated under sub-paragraph (b)(iv)(f) of sub-
9 section (2) of section 2 of this act for which the allottee
10 shall be the Luhken Menlap of the Kitti Municipal Government
11 and the Isokohnedi of Kitti. The allottee of the funds
12 appropriated under sub-paragraph (c) of subsection (2) of
13 section 2 of this act shall be the Kolonia Town Mayor. The
14 allottee of the funds appropriated under sub-paragraph (i)
15 of subsection (2) of section 2 of this act shall be the
16 Luhkenkolwof of Sapwuahfik. The allottee of the funds
17 appropriated under sub-paragraph (j) of subsection (2) of
18 section 2 of this act shall be the Chief Magistrate of the
19 Nukuoro Municipal Government. The allottee of the funds
20 appropriated under sub-paragraph (k)(i) of subsection (2)
21 of section 2 of this act shall be the Chief Magistrate of
22 the Kapungamarangi Municipal Government. The allottee of
23 the funds appropriated under subsection (3) of section 2 of
24 this act shall be the Chairman of the Pohnpei Congressional
25 Delegation. Each allottee shall be responsible for ensuring

1 that these funds, or so much thereof as may be necessary,
2 are used solely for the purposes specified in this act, and
3 that no obligations are incurred in excess of the sum
4 appropriated. The authority of the allottees to obligate
5 funds appropriated by this act shall lapse as of September
6 30, 1990."

7 Section 3. This act shall become law upon approval by the
8 President of the Federated States of Micronesia or upon its becoming
9 law without such approval.
