Public Law No. 6 - 25

AN ACT

To appropriate the sum of \$500,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, for the purpose of funding pre-convention expenses relating to the Constitutional Convention, the Constitutional Convention itself, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$250,000, or so much thereof as may be
- 2 necessary, is hereby appropriated from the General Fund of the
- 3 Federated States of Micronesia for the fiscal year ending September 30,
- 4 1990, for the purpose of providing for the conduct of the election of
- 5 delegates, the travel and per diem expenses of the Pre-Convention
- 6 Committee, and other Pre-Convention expenses.
- 7 Section 2. The sum appropriated under section 1 of this act
- 8 shall be apportioned as follows:
- 9 (1) Pre-Convention Committee per diem, travel, and
- 10 other expenses.....\$ 25,000
- 11 (2) Election of Delegates from Yap..... 60,000
- 12 (3) Election of Delegates from Truk...... 102,000
- 13 (4) Election of Delegates from Kosrae...... 10,000
- 14 (5) Election of Delegates from Pohnpei...... 53,000
- 15 Section 3. The sum of \$250,000, or so much thereof as may be
- 16 necessary, is hereby appropriated from the General Fund of the Federated
- 17 States of Micronesia for the fiscal year ending September 30, 1990, for
- 18 the purpose of funding the Constitutional Convention.
- 19 Section 4. No funds which have been appropriated by this act for
- 20 the election of the delegates to the Constitutional Convention shall
- 21 be released to any State without a submission of a budget and a cost
- 22 breakdown.

1	Section 5. All funds appropriated by this act shall be allotted,
2	managed, administered, and accounted for in accordance with applicable
3	law, including, but not limited to, the Financial Management Act of
4	1979. The allottee shall be the President of the Federated States of
5	Micronesia or his designated representative who shall be responsible
6	for ensuring that these funds, or so much thereof as may be necessary,
7	are used solely for the purposes specified in this act, and that no
8	obligations are incurred in excess of the sum appropriated. The
9	authority of the allottee to obligate funds appropriated by this act
10	shall lapse as of September 30, 1990.
11	Section 6. This act shall become law upon approval by the
12	President of the Federated States of Micronesia or upon its becoming
13	law without such approval.
