

A BILL FOR AN ACT

To appropriate the sum of \$2,210,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, for the purpose of funding statewide and other public projects in Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Statewide public projects. The sum of \$200,000, or  
2 so much thereof as may be necessary, is hereby appropriated from the  
3 General Fund of the Federated States of Micronesia for the fiscal  
4 year ending September 30, 1990, for the purpose of funding certain  
5 statewide public projects in Chuuk State. The sum appropriated by  
6 this section shall be apportioned as follows:

7 (1) Two magnet high schools on Moen, with an equal  
8 amount to be contributed by Chuuk State ..... \$100,000

9 (2) Upgrading Junior high schools to senior high  
10 schools, with an equal amount to be contributed by Chuuk  
11 State ..... 100,000

12 Section 2. Northern Namoneas public projects. The sum of  
13 \$400,000, or so much thereof as may be necessary, is hereby appro-  
14 priated from the General Fund of the Federated States of Micronesia  
15 for the fiscal year ending September 30, 1990, for the purpose of  
16 funding certain public projects in Northern Namoneas, Chuuk State.

17 The sum appropriated by this section shall be apportioned as follows:

18 (1) Economic and social projects ..... \$400,000

19 Section 3. Southern Namoneas public projects. The sum of  
20 \$460,000, or so much thereof as may be necessary, is hereby appro-  
21 priated from the General Fund of the Federated States of Micronesia  
22 for the fiscal year ending September 30, 1990, for the purpose of  
23 funding certain public projects in Southern Namoneas, Chuuk State.

24 The sum appropriated by this section shall be apportioned as follows:

25 (1) Economic and social projects ..... \$460,000

1           Section 4. Faichuk public projects. The sum of \$500,000, or  
2 so much thereof as may be necessary, is hereby appropriated from the  
3 General Fund of the Federated States of Micronesia for the fiscal  
4 year ending September 30, 1990, for the purpose of funding certain  
5 public projects in Faichuk, Chuuk State. The sum appropriated by  
6 this section shall be apportioned as follows:

7                   (1) Economic and social projects ..... \$500,000

8           Section 5. Mortlocks public projects. The sum of \$400,000, or  
9 so much thereof as may be necessary, is hereby appropriated from the  
10 General Fund of the Federated States of Micronesia for the fiscal  
11 year ending September 30, 1990, for the purpose of funding certain  
12 public projects in the Mortlocks Islands, Chuuk State. The sum  
13 appropriated by this section shall be apportioned as follows:

14                   (1) Economic and social projects ..... \$400,000

15           Section 6. Pattiw, Weito, and Hall Islands public projects.  
16 The sum of \$250,000, or so much thereof as may be necessary, is  
17 hereby appropriated from the General Fund of the Federated States of  
18 Micronesia for the fiscal year ending September 30, 1990, for the  
19 purpose of funding certain public projects in the Pattiw, Weito, and  
20 Hall Islands, Chuuk State. The sum appropriated by this section  
21 shall be apportioned as follows:

22                   (1) Economic and social projects ..... \$250,000

23           Section 7. Allotment and management of funds and lapse date.

24 All funds appropriated by this act shall be allotted, managed,  
25 administered, and accounted for in accordance with applicable


1 law, including, but not limited to, the Financial Management Act  
2 of 1979. The allottee shall be the President of the Federated States  
3 of Micronesia who shall be responsible for ensuring that these funds,  
4 or so much thereof as may be necessary, are used solely for the  
5 purposes specified in this act, and that no obligations are incurred  
6 in excess of the sum appropriated. The authority of the allottee to  
7 obligate funds appropriated by this act shall not lapse until  
8 expended.

9       Section 8. Effective date. This act shall become law upon  
10 approval by the President of the Federated States of Micronesia or  
11 upon its becoming law without such approval.
