A BILL FOR AN ACT

To appropriate the sum of \$2,140,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1991, for the purpose of funding social and economic projects in Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Faichuk public projects. The sum of \$550,000, or so
2 much thereof as may be necessary, is hereby appropriated from the
3 General Fund of the Federated States of Micronesia for the fiscal
4 year ending September 30, 1991, for the purpose of funding certain
5 public projects in Faichuk, Chuuk State. The sum appropriated by
6 this section shall be apportioned as follows:

7 (1) Economic and social projects\$550,000

8 Section 2. Southern Namoneas public projects. The sum of
9 \$520,000, or so much thereof as may be necessary, is hereby
10 appropriated from the General Fund of the Federated States of
11 Micronesia for the fiscal year ending September 30, 1991, for the
12 purpose of funding certain public projects in Southern Namoneas,
13 Chuuk State. The sum appropriated by this section shall be
14 apportioned as follows:

15 (1) Economic and social projects\$520,000

16 Section 3. Mortlocks public projects. The sum of \$420,000, or
17 so much thereof as may be necessary, is hereby appropriated from the
18 General Fund of the Federated States of Micronesia for the fiscal
19 year ending September 30, 1991, for the purpose of funding certain
20 public projects in the Mortlocks Islands, Chuuk State. The sum
21 appropriated by this section shall be apportioned as follows:

22 (1) Economic and social projects\$420,000

23 Section 4. Northern Namoneas public projects. The sum of
24 \$400,000, or so much thereof as may be necessary, is hereby
25 appropriated from the General Fund of the Federated States of

1 Micronesia for the fiscal year ending September 30, 1991, for the
2 purpose of funding certain public projects in Northern Namoneas,
3 Chuuk State. The sum appropriated by this section shall be
4 apportioned as follows:

5 (1) Economic and social projects\$400,000

6 Section 5. Pattiw, Weito, and Hall Islands public projects.

7 The sum of \$250,000, or so much thereof as may be necessary, is
8 hereby appropriated from the General Fund of the Federated States of
9 Micronesia for the fiscal year ending September 30, 1991, for the
10 purpose of funding certain public projects in the Pattiw, Weito, and
11 Hall Islands, Chuuk State. The sum appropriated by this section
12 shall be apportioned as follows:

13 (1) Economic and social projects\$250,000

14 Section 6. Allotment and management of funds and lapse date.

15 All funds appropriated by this act shall be allotted, managed,
16 administered, and accounted for in accordance with applicable law,
17 including, but not limited to, the Financial Management Act of 1979.
18 The allottee shall be the President of the Federated States of
19 Micronesia and shall be responsible for ensuring that these funds, or
20 so much thereof as may be necessary, are used solely for the purpose
21 specified in this act, and that no obligations are incurred in excess
22 of the sum appropriated. The authority of the allottee to obligate
23 funds appropriated by this act shall not lapse.


