AN ACT

To further amend Public Law No. 5-80, as amended, by further amending section 2, as amended by Public Laws Nos. 5-108, 6-34, 7-50 and 7-65, for the purpose of modifying the use of funds previously appropriated for public projects in Kosrae State, and by further amending section 3, as amended by Public Laws Nos. 6-34, 7-15 and 7-52, for the purpose of changing the allottee of certain projects appropriated therein, and for other purposes.

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
