CONGRESSIONAL BILL NO. 7-163

AN ACT

To further amend Public Law No. 4-92, as amended by Public Laws Nos. 4-108 and 7-4, by further amending section 2, as amended by Public Laws Nos. 4-108 and 7-4, Kosrae State public projects, to modify the use of funds appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 4-92, as amended by Public  
2 Laws Nos. 4-108 and 7-4, is hereby further amended to read as follows:
