## AN ACT

To further amend section 3 of Public Law No. 6-89, as amended by Public Law No. 7-7, Kosrae State public projects, to modify the allottee of certain funds appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 3 of Public Law No. 6-89, as amended by Public Law No. 7-7, is hereby further amended to read as follows: 3 "Section 3. All funds appropriated by this act shall be allotted, managed, administered, and accounted for in 4 5 accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. The allottee of 6 the funds appropriated under subsections (1) and (5) of 7 8 section 2 of this act, and paragraphs (3)(c), (3)(d), 9 (3)(e), (3)(f), (3)(g), (3)(h), (4)(a), (4)(b), (4)(d), 10 (4)(e), (4)(f) and (4)(g) of section 2 of this act shall be the Chairman of the KSCIP. The allottee of the funds 11 appropriated under subsection (2) of section 2 of this act 12 13 shall be the Mayor of Lelu Municipality. The allottee of the funds appropriated under paragraphs (3)(a) and (3)(b) 14 of section 2 of this act shall be the Mayor of Tafunsak 15 Municipality. The allottee of the funds appropriated under 16 paragraph (4)(c) of section 2 of this act shall be the 17 Mayor of Malem Municipality. The allottee of the funds 18 19 appropriated under subsection (6) of section 2 of this 20 act shall be the Chairman of the Kosrae Congressional Delegation. The allottees shall be responsible for 21 22 ensuring that these funds, or so much thereof as may be

1	necessary, are used solely for the purposes specified in
2	this act, and that no obligations are incurred in excess of
3	the sum appropriated. The authority of the allottees to
4	obligate funds appropriated by this act shall not lapse
5	until expended."
6	Section 2. This act shall become law upon approval by the
7	President of the Federated States of Micronesia or upon its becoming
8	law without such approval.
