A BILL FOR AN ACT

To amend Public Law No. 7-104 by amending sections 1 and 2 to restrict the use of appropriated funds to expenses related to the regular General National Congressional Election held in March, 1993 and to shorten the lapse date for the obligation of appropriated funds; to further amend Public Law No. 7-78, as amended by Public Laws Nos. 7-80, 7-111, 7-113, 7-127, and 7-129, by amending section 12 to restrict the use of appropriated funds; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 1 of Public Law No. 7-104 is hereby amended to read as follows:
2	"Section 1. The sum of \$247,000, or so much thereof as may be necessary, is hereby
3	appropriated from the General Fund of the Federated States of Micronesia for the fiscal
4	year ending September 30, 1993, for the purpose of funding the regular General
5	National Congressional Election to be held in March of 1993. The sum appropriated
6	under this section shall be apportioned as follows:
7	(1) Kosrae\$ 12,000
8	(2) Chuuk 115,000
9	(3) Pohnpei 55,000
10	(4) Yap 65,000
11	None of the funds appropriated under subsection (2) of this section shall be expended for
12	travel outside of the Federated States of Micronesia or for expenses related to any
13	election or balloting held or conducted for any purpose after March 15, 1993."
14	Section 2. Section 2 of Public Law No. 7-104 is hereby amended to read as follows:
15	"Section 2. All funds appropriated by this act shall be allotted, managed, administered,
16	and accounted for in accordance with applicable law, including, but not limited to, the
17	Financial Management Act of 1979. The allottee of the funds appropriated under section
18	1 of this act shall be the President of the Federated States of Micronesia. The allottee
19	shall be responsible for ensuring that these funds, or so much thereof as may be
20	necessary, are used solely for the purpose specified in this act, and that no obligations
21	are incurred in excess of the sum appropriated. The authority of the allottee to obligate
22	funds appropriated by this act shall lapse as of \$eptenblot 30 May 2, 1993."
23	Section 3. Section 12 of Public Law No. 7-78 is hereby amended to read as follows:
24	"Section 12. Other National Government programs, grants, subsidies, contributions,
25	and refunds. The sum of \$2,781,287, or so much thereof as may be necessary, is
