

A BILL FOR AN ACT

To further amend Public Law No. 7-117, as amended by Public Laws Nos. 7-136, 8-11 and 8-14, by further amending section 8, as amended by Public Law No. 7-136, for the purpose of changing the allottee of funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 8 of Public Law No. 7-117, as amended by
2 Public Law No. 7-136, is hereby further amended to read as follows:


3 "Section 8. All funds appropriated by this act shall be
4 allotted, managed, administered, and accounted for in
5 accordance with applicable law, including, but not limited
6 to, the Financial Management Act of 1979. The allottee of
7 the funds appropriated under subsections (1), (2) and
8 (4)(a) of section 1 of this act shall be the President of
9 the Federated States of Micronesia. The allottee of the
10 funds appropriated under subsection (4)(b) of section 1 of
11 this act shall be the Pattiw Social and Economic
12 Development Authority. The allottee of the funds
13 appropriated under subsection (3) of section 1 of this act
14 shall be the Lower Mortlocks Development Authority. The
15 allottee of the funds appropriated under section 2 of this
16 act shall be the Chairman of the KSCIP. The allottee of
17 the funds appropriated under subsection (1) of section
18 3 of this act shall be the Pohnpei Port Authority. The
19 allottee of the funds appropriated under subsection (2) of
20 section 3 of this act shall be the Pohnpei Community Action
21 Agency. The allottee of the funds appropriated under
22 subsection (1) of section 5 of this act shall be the
23 Pohnpei Transportation Authority. The allottee of the
24 funds appropriated under subsection (2) of section 5 of
25 this act shall be the Pohnpei Community Action Agency. The

1 allottee of the funds appropriated under subsection (1) of
2 section 6 of this act shall be the Chief Executive Officer
3 of Madolenihmw Municipality, Pohnpei State. The allottee
4 of the funds appropriated under subsection (2) of section 6
5 of this act shall be the Chief Executive Officer of Kitti
6 Municipality, Pohnpei State. The allottee of the funds
7 appropriated under section 7 of this act shall be the PWP
8 Development Authority. The allottees shall be responsible
9 for ensuring that these funds, or so much thereof as may be
10 necessary, are used solely for the purposes specified in
11 this act, and that no obligations are incurred in excess of
12 the sum appropriated. The authority of the allottees to
13 obligate funds appropriated by this act shall lapse as of
14 September 30, 1994."

15 Section 2. This act shall become law upon approval by the
16 President of the Federated States of Micronesia or upon its becoming
17 law without such approval.
