A BILL FOR AN ACT

To amend Public Law No. 8-113, by amending section 1 to reallocate funds appropriated therein; by adding new sections 2, 3, 4 and 5 to separate by State the funds appropriated in section 1; by amending section 2 to renumber and designate allottees; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1           Section 1. Section 1 of Public Law No. 8-113 is hereby amended to  
2   read as follows:  
3           "Section 1. The sum of \$3,050,000 800,000, or so much thereof  
4           as may be necessary, is hereby appropriated from the General  
5           Fund of the Federated States of Micronesia for the fiscal year  
6           ending September 30, 1995, for the purpose of providing funding  
7           for social and economic development projects relatd to it each of  
8           ~~the States~~ Chuuk State. The funds appropriated by this act shall  
9           be apportioned and allocated as follows:

12 Section 2. Public Law No. 8-113 is hereby amended by adding a new section  
13 2 to read as follows:

14 "Section 2. The sum of \$1,200,000, or so much thereof as may  
15 be necessary, is hereby appropriated from the General Fund of  
16 the Federated States of Micronesia for the fiscal year ending  
17 September 30, 1995, for the purpose of providing funding for  
18 social and economic development projects related to Pohnpei  
19 State. The funds appropriated by this act shall be apportioned  
20 and allocated as follows:

21	(1) Pohnpei Terminal improvement and	
22	renovation.....	100,000
23	(2) Other.....	1,000,000"

24 Section 3. Public Law No. 8-113 is hereby amended by adding a new  
25 section 3 to read as follows:

"Section 3. The sum of \$300,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for the purpose of providing funding for social and economic development projects related to Yap State. The funds appropriated by this act shall be apportioned and allocated as follows:

(1) Yap State International Airport..... \$200,000

(2) Other public projects

(a) Repair and renovation Falalop

Ulithi Dispensary..... 35,000

(b) Rang/Gilfith basketball court..... 15,000

(c) Gilmar Elementary School..... 20,000

(d) Tomil Elementary School..... 30,000

Section 4. Public Law No. 8-113 is hereby amended by adding a new section 4 to read as follows:

"Section 4. The sum of \$250,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for the purpose of providing funding for social and economic development projects related to Kosrae State. The funds appropriated by this act shall be apportioned and allocated as follows:

(1) Kosrae State..... \$250,000"

Section 5. Public Law No. 8-113 is hereby amended by adding a new

1 section 5 to read as follows:

2 "Section 5. The sum of \$500,000, or so much thereof as may be  
3 necessary, is hereby appropriated from the General Fund of the  
4 Federated States of Micronesia for the fiscal year ending  
5 September 30, 1995, for the purpose of providing funding for  
6 the National Airline Corporation.


7 (1) Funding for the National Airline Corporation. \$500,000"

8 Section 6. Section 2 of Public Law No. 8-113 is hereby amended to  
9 read as follows:

10 "Section ~~2~~6. All funds appropriated by this act shall be  
11 allotted, managed, administered, and accounted for in  
12 accordance with applicable law, including, but not limited to,  
13 the Financial Management Act of 1979. The allottee of the  
14 funds appropriated under subsections ~~(1)(a)~~, ~~of section 1(1)(c)~~  
15 ~~(3)~~ and ~~(1)(d)(4)~~ of section 1 of this act shall be the National  
16 Planner of the Office of Planning and Statistics of the  
17 Federated States of Micronesia, or his designee. The allottee  
18 of the funds appropriated by subsection ~~(1)(b)(2)~~ of section 1 of  
19 this act shall be the Southern Namoneas Authority. The  
20 allottee of the funds appropriated by subsection ~~(1)(d)(1)(5)(a)~~  
21 of section 1 of this act shall be the Hall Islands Development  
22 Authority. The allottee of the funds appropriated by  
23 subsection ~~(1)(f)(6)~~ of section 1 of this act shall be the  
24 Executive Director of the Chuuk Organization for Community  
25 Action. The allottee of the funds appropriated by subsection 7

1 of section 1 of this act shall be the Governor of Chuuk State.  
 2 The allottee of the funds appropriated under subsection (8) of  
 3 section 1 of this act shall be the Speaker of the Congress  
 4 the Federated States of Micronesia. The allottee of the funds  
 5 appropriated by ~~sections 112, 114 and 115 of~~ ~~sections 112, 114 and 115 of~~  
 6 ~~this act~~ of this act shall be the President of the Federated States of  
 7 Micronesia, or the President's designee. The allottee of the  
 8 funds appropriated under ~~section 13 of~~ ~~section 13 of~~ of this act  
 9 shall be the Governor of the State of Yap. The allottees shall  
 10 be responsible for ensuring that these funds or so much thereof  
 11 as may be necessary, are used solely for the purposes specified  
 12 in this act, and that no obligations are incurred in excess of  
 13 the sums appropriated. The authority of the allottees to  
 14 obligate funds appropriated by this act shall not lapse."

15 Section 7. This act shall become law upon approval by the President  
 16 of the Federated States of Micronesia or upon its becoming law without such  
 17 approval.
