To further amend Public Law No. 8-93, as amended by Public Law No. 8-98, by further amending section 2, as amended by Public Law No. 8-98, for the purpose of designating the allottee of certain funds previously appropriated for school needs throughout the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- Section 1. Section 2 of Public Law No. 8-93, as amended by Public

2	allottees to obligate funds appropriated by this act shall not
3	lapse."
4	Section 2. This act shall become law upon approval by the President
