ANACT

To further amend Public Law No. 8-75, as amended by Public Laws Nos. 8-79 and 8-116, by further amending section 2, as amended by Public Laws Nos. 8-79 and 8-116, to change the use of funds previously appropriated therein; by further amending section 3, as amended by Public Laws Nos. 8-79 and 8-116, for the purpose of designating the allottees of funds; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 8-75, as amended by Public Laws Nos. 8-79
2 and 8-116, is hereby further amended to read as follows:



11	Section 2. Section 3 of Public Law No. 8-75, as amended by Public Laws Nos. 8-79	
12	and 8-116, is hereby further amended to read as follows:	
13	"Section 3. All funds appropriated by this act shall be allotted, managed,	
14	administered, and accounted for in accordance with applicable law,	
15	including, but not limited to, the Financial Management Act of 1979. The	
16	allottee of the funds appropriated under subsection (1)(a) of section 2 of	
17	this act shall be the PWP Development Authority. The allottee of the funds	
18	appropriated under subsections (1)(b)(i), (1)(b)(ii), (1)(b)(iii) and	
19	(1)(b)(iv) of section 2 of this act shall be the Mayor of Fono. The allottee	
20	of the funds appropriated under subsections (1)(b)(v), (1)(b)(vi) and	
21	(1)(b)(vii) of section 2 of this act shall be the Mayor of Pis-Paneu. The	
22	allottee of the funds appropriated under subsections (1)(b)(viii),	
23	(1)(b)(x), (1)(b)(xi), and (1)(b)(xvii) of section 2 of this act shall be	
24	the Mayor of Weno. The allottee of the funds appropriated under	
25	subsections (1)(b)(ix), (1)(b)(xii), (1)(b)(xiii), (1)(b)(xiv),	

1 (1)(b)(xv), (1)(b)(xvi), and (1)(b)(xviii) of section 2 of this act
2 shall be the Weno Projects Coordinator. The allottee of the funds
3 appropriated under subsection (1)(c) of section 2 of this act shall be the
4 Southern Namoneas Development Authority. The allottee of the funds
5 appropriated under subsection (1)(d) of section 2 of this act shall be the
6 Lower Mortlocks Development Authority. The allottee of the funds
7 appropriated under subsections (1)(e)(i), (1)(e)(ii) and (1)(e)(iii) of
8 section 2 of this act shall be the Executive Director of the Hall Development
9 Authority. The allottee of the funds appropriated under subsections
10 (1)(e)(iv), (1)(e)(v) and (1)(e)(vi) of section 2 of this act shall be the
11 Weito Development Authority. The allottee of the funds appropriated under
12 subsections (1)(e)(vii), (1)(e)(viii), (1)(e)(ix), (1)(e)(x),
13 (1)(e)(xi)a), (1)(e)(xii) and (1)(e)(xiii) of section 2 of this act shall
14 be the Pattiw Development Authority. The allottee of the funds
15 appropriated under subsection (1)(e)(xi)b) of section 2 of this act shall
16 be the Director of Public Safety for the State of Chuuk. The allottee of the
17 funds appropriated under subsection (1)(e)(xi)c) of section 2 of this act
18 shall be the Director of the Chuuk State Department of Agriculture. The
19 allottee of the funds appropriated under subsections (1)(f)(i) and
20 (1)(f)(ii) of section 2 of this act shall be the Executive Director of COCA.
21 The allottee of the funds appropriated under subsections (1)(f)(iii),
22 (1)(f)(iv) and (1)(f)(v) of section 2 of this act shall be the Governor of
23 the State of Chuuk. The allottee of the funds appropriated under subsection
24 (1)(f)(vi) of section 2 of this act shall be the Lower Mortlocks
25 Development Authority. The allottee of the funds appropriated under

1 subsection (2)(a)(i) of section 2 of this act shall be the Luhkenkolwof of
2 Sapwuafik. The allottee of the funds appropriated under subsection
3 (2)(a)(ii) of section 2 of this act shall be the Chief Magistrate of Nukuoro.
4 The allottee of the funds appropriated under subsection (2)(a)(iii) of
5 section 2 of this act shall be the Chief Magistrate of Kapingamarangi. The
6 allottee of the funds appropriated under subsection (2)(a)(iv) of section 2
7 of this act shall be the Mayor of Kolonia Town. The allottee of the funds
8 appropriated under subsections (2)(a)(v)a), (2)(a)(v)b) and 2(a)(v)i)
9 of section 2 of this act shall be the Chief Magistrate of Sokehs. The allottee
10 of the funds appropriated under subsections (2)(b), (2)(c), (2)(e),
11 (2)(f), (4)(b), (4)(c), (4)(d), (4)(e), (4)(f), (4)(g), (4)(h),
12 (4)(i), (4)(j) and (4)(k) of section 2 of this act shall be the President of
13 the Federated States of Micronesia. The allottee of funds appropriated under
14 subsection (2)(a)(v)c) of section 2 of this act shall be the Pohnpei Utility
15 Corporation. The allottee of funds appropriated under subsection (2)(d) of
16 section 2 of this act shall be the Pohnpei Transportation Authority. The
17 allottee of the funds appropriated under subsection 3 of section 2 of this act
18 shall be the Governor of the State of Yap or his designee. The allottee of the
19 funds appropriated under subsection (4)(a) of section 2 of this act shall be
20 the Chairman of the Kosrae Sports Council. The allottee of the funds
21 appropriated under subsections (4)(l) and (4)(n) of section 2 of this act
22 shall be the Mayor of the Lelu Municipal Government. The allottee of the
23 funds appropriated under subsections (4)(m) and (4)(o) of section 2 of
24 this act shall be the Mayor of the Malem Municipal Government. The
25 allottee of the funds appropriated under subsection (4)(p) of section 2 of

1 this act shall be the Mayor of the Utwe Municipal Government. The allottee
 2 of the funds appropriated under subsection (4)(q) of section 2 of this act
 3 shall be the Mayor of the Tafunsak Municipal Government. The allottees
 4 shall be responsible for ensuring that these funds, or so much thereof as
 5 may be necessary, are used solely for the purposes specified in this act, and
 6 that no obligations are incurred in excess of the sum appropriated. The
 7 authority of the allottees to obligate funds appropriated by this act shall not
 8 lapse."

9 Section 3. This act shall become law upon approval by the President of the Federated
 10 States of Micronesia or upon its becoming law without such approval.
