All funds appropriated by this act shall be 4 allotted, managed, administered, and accounted for in 5 accordance with applicable law, including, but not limited 6 to, the Financial Management Act of 1979. The allottee of 7 the funds appropriated under subsection (1)(a) of section 2 8 of this act shall be the Faichuk PWP Development Authority. 9 The allottee of the funds appropriated under subsection 10 (1)(b) of section 2 of this act shall be the Secretary of 11 the Department of Health Services. The allottee of the funds 12 appropriated under subsection (1)(c) of section 2 of this 13 act shall be the Lower Mortlocks Development Authority. 14 The allottee of the funds appropriated under subsection 15 (1)(d)(i) of section 2 of this act shall be the Hall Islands 16 Development Authority. The allottee of the funds 17 appropriated under subsection (1)(d)(ii) of section 2 of 18 this act shall be the Nomunwito Development Authority. 19 The allottee of the funds appropriated under subsections 20 (1)(d)(iii) and (1)(d)(iv) of section 2 of this act shall 21 be the Pattiw Development Authority. The allottee for all 22 other funds appropriated under this act shall be the 23 President or the President's designee; PROVIDED, the 24

allottee of the funds appropriated under subsection (3) of

1	section 2 of this act shall be the Governor of the State of
2	Yap. The allottees shall be responsible for ensuring that
3	these funds, or so much thereof as may be necessary, are
4	used solely for the purposes specified in this act, and that
5	no obligations are incurred in excess of the sum
6	appropriated. The authority of the allottees to obligate
7	funds appropriated by this act shall lapse as of
8	September 30, 1995."
9	Section 3. This act shall become law upon approval by the
10	President of the Federated States of Micronesia or upon its becoming
11	law without such approval.
