

AN ACT

To further amend Public Law No. 7-35, as amended, Chuuk State public projects, by further amending section 1, as amended by Public Laws Nos. 7-43, 7-68 and 8-34, to modify the use of funds previously appropriated for statewide public projects; by amending section 5 for the purpose of modifying funds previously appropriated for the Mortlocks in Chuuk State; by further amending section 8, as amended by Public Laws Nos. 7-43, 8-17 and 8-34, for the purpose of changing the allottee of funds previously appropriated therein; by repealing section 2 of Public Law No. 8-34; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 7-35, as amended by Public
2 Laws Nos. 7-43, 7-68 and 8-34, is hereby further amended to read as
3 follows:

4 "Section 1. Statewide public projects. The sum of \$400,000,
5 or so much thereof as may be necessary, is hereby appropriated
6 from the General Fund of the Federated States of Micronesia
7 for the fiscal year ending September 30, 1992, for the purpose
8 of funding statewide public projects in the State of Chuuk.

9 The sum appropriated by this section shall be apportioned as
10 follows:

14	Section 2. Section 5 of Public Law No. 7-35 is hereby amended	
15	to read as follows:	
16	"Section 5. <u>Mortlocks public projects.</u> The sum of	
17	\$525,000, or so much thereof as may be necessary, is hereby	
18	appropriated from the General Fund of the Federated States	
19	of Micronesia for the fiscal year ending September 30,	
20	1992, for the purpose of funding public projects in the	
21	Mortlocks Islands, Chuuk State. The sum appropriated by	
22	this section shall be apportioned as follows:	
23	(1) Municipal Constitutional Convention	
24	activities.....	\$ 224,963.94
25	(2) Other public projects.....	280,043.95

1	(3) Aurauou project.....	\$ 4,000.00
2	(4) Kuttu Co-op.....	3,000.00

6 Section 3. Section 2 of Public Law No. 8-34 is hereby repealed
7 in its entirety.

8 Section 4. Section 8 of Public Law No. 7-35, as amended by Public
9 Laws Nos. 7-43, 8-17 and 8-34, is hereby further amended to read as
10 follows:

11 "Section 8. All funds appropriated by this act shall be
12 allotted, managed, administered, and accounted for in
13 accordance with applicable law, including, but not limited
14 to, the Financial Management Act of 1979. The allottee of
15 the funds appropriated under section 1 of this act shall be
16 the Governor of Chuuk State; the allottee of the funds
17 appropriated under subsections (1), (2), (3), (5), (6), (7),
18 (8), (9), (10), (11) and (12) of section 2 of this act
19 shall be the Mayor of Weno Municipality; the allottee of
20 the funds appropriated under subsection (4) of section 2
21 of this act shall be the Mayor of Fono Municipality; the
22 allottee of the funds appropriated under section 4 of this
23 act shall be the Faichuk PWP Development Authority; the
24 allottee of the funds appropriated under section 5 of this
25 act shall be the Lower Mortlocks Development Authority; the

1 allottee of the funds appropriated under section 6 shall be
2 the local development authorities of the areas for which
3 the funds are designated; and the allottee of the funds
4 appropriated under sections 3, 7(1) and 7(2) of this
5 act shall be the Southern Namoneas Development Authority.
6 The allottee of the funds appropriated under section 7(3)
7 of this act shall be the School Board of the Saramen Chuuk
8 Academy. The allottees shall be responsible for ensuring
9 that these funds, or so much thereof as may be necessary,
10 are used solely for the purposes specified in this act,
11 and that no obligations are incurred in excess of the sums
12 appropriated. The authority of the allottees to obligate
13 funds appropriated by this act shall not lapse."

14 Section 5. This act shall become law upon approval by the
15 President of the Federated States of Micronesia or upon its becoming
16 law without such approval.
