## A RESOLUTION

To ratify the Amendments to the Articles of Agreement establishing the Treaty on Fisheries between the Governments of Certain Pacific Island States and the Government of the United States (hereinafter referred to as the Multilateral Fisheries Treaty), as amended.

- 1 WHEREAS, the Treaty on Fisheries between the Governments of
- 2 Certain Pacific Island States and the Government of the United
- 3 States (hereinafter referred to as the Multilateral Fisheries
- 4 Treaty), was ratified by the Congress of the Federated States of
- 5 Micronesia on May 29, 1987; and
- 6 WHEREAS, the parties met in December of 1991 and May of 1992
- 7 to consider an extension of the Multilateral Fisheries Treaty
- 8 and have agreed to extend said Treaty for a period of 10 years,
- 9 with a review before the fifth year, starting from June 15,
- 10 1993, respecting the financial and licensing arrangements; and
- 11 WHEREAS, the Multilateral Fisheries Treaty itself was not
- 12 amended but its annexes and schedules; and
- 13 WHEREAS, the United States Government has agreed to make
- 14 annual cash payments to the Forum Fisheries Agency (FFA) in an
- 15 average amount of \$18,000,000, an increase over the current
- 16 \$10,000,000; and
- WHEREAS, the amendments to the Annexes of the Multilateral
- 18 Fisheries Treaty include among others the following: a new Part
- 19 4 regarding transshipment of fish; a new subpart under Part 7
- 20 entitled "Observers," which imposes responsibility for the cost
- 21 of observers, including full travel costs, salary and
- 22 allowances, full insurance coverage, and the cost of training
- 23 observers on the operations of U.S. vessels; a new subpart under
- 24 Part 8 entitled "Miscellaneous Requirements," which establishes
- 25 a region-wide vessel tracking system which shall be applicable

1 to all U.S. vessels licensed to fish in the treaty area; a new

- 2 paragraph 5(c)(i)(D) in Annex II regarding suspension of good
- 3 standing of a vessel when a violation has occurred; and a new
- 4 paragraph 6 in Annex II, where the Pacific Island Parties
- 5 consider notifying the Government of the United States of any
- 6 alleged infringements of the Treaty by vessels of the United
- 7 States 30 days prior to requesting an investigation under
- 8 paragraph 4 of Article 4 of the Treaty; and
- 9 WHEREAS, the Multilateral Fisheries Treaty shall enter into
- 10 force on June 15, 1993 and shall remain in force for 10 years
- 11 unless amended or terminated by either party; and
- 12 WHEREAS, the Multilateral Fisheries Treaty as amended is in
- 13 the best interest of the FSM National Government; now,
- 14 therefore,
- BE IT RESOLVED by the Eighth Congress of the Federated
- 16 States of Micronesia, First Regular Session, 1993, that pursuant
- 17 to section 2(b) of article IX of the Constitution of the
- 18 Federated States of Micronesia the Congress hereby ratifies the
- 19 Amendments to the Articles of Agreement establishing the Treaty
- 20 on Fisheries between the Governments of Certain Pacific Island
- 21 States and the Government of the United States; and
