

A BILL FOR AN ACT

To appropriate the sum of \$394,449 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for the purpose of reappropriating certain funds which lapsed September 30, 1994, under Public Law No. 7-117, as amended, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$393,574 or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the Federated
3 States of Micronesia for the fiscal year ending September 30, 1995, for the
4 purpose of constructing and/or improving roads, docks and/or airports in
5 Chuuk State. The funds appropriated under subsection (4) of this section are
6 to be expended only if they have first been matched by the State and/or
7 municipal governments of Chuuk State. The sum appropriated under this
8 section shall be apportioned as follows:

2 Section 2. The sum of \$875 or so much thereof as may be necessary, is
3 hereby appropriated from the General Fund of the Federated States of
4 Micronesia for the fiscal year ending September 30, 1995, for the purpose of
5 constructing and/or improving roads, bridges and causeways, and for funding
6 economic and social development projects in Faichuk, Chuuk State. The sum
7 appropriated under this section shall be apportioned as follows:

8 (1) Faichuk fishing apprenticeship fund..... \$ 222

9 (2) Fanapanges fishing program 271

10 (3) Romalum fishing program 320

11 (4) Eot fiberglass boat construction

12 apprenticeship and trainee project..... 62

13 Section 3. All funds appropriated by this act shall be allotted, managed,
14 administered, and accounted for in accordance with applicable law, including,
15 but not limited to, the Financial Management Act of 1979. The allottee of the
16 funds appropriated under subsections (1) and (2) of section 1 of this act shall
17 be the President of the Federated States of Micronesia. The allottee of the fund
18 appropriated under subsection (3) of section 1 of this act shall be the Lower
19 Mortlocks Development Authority. The allottee of the funds appropriated under
20 subsection (4)(a) of section 1 of this act shall be the Hall Islands Development
21 Authority. The allottee of the funds appropriated under subsections (4)(b) and
22 (4)(c) of section 1 of this act shall be the Pattiw Social and Economic
23 Development Authority. The allottee of the funds appropriated under section 2
24 of this act shall be the PWP Development Authority. The allottees shall be
25 responsible for ensuring that these funds, or so much thereof as may be

1 necessary, are used solely for the purposes specified in this act, and that no
2 obligations are incurred in excess of the sum appropriated. The authority of
3 the allottees to obligate funds appropriated by this act shall lapse as of
4 September 30, 1995.

5 Section 4. This act shall become law upon approval by the President of
6 the Federated States of Micronesia or upon its becoming law without such
7 approval.
