A BILL FOR AN ACT

To further amend Public Law No. 8-113, as amended by Public Laws Nos. 8-129 and 8-139, by further amending section 2 thereof, as amended by Public Law No. 8-129, for the purpose of changing an allottee of funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Secti	on 1. Section 2 of Public Law No. 8-113, as amended by Public
2	Law No. 8-	129, is hereby further amended to read as follows:
3		"Section 6. All funds appropriated by this act shall be
4		allotted, managed, administered, and accounted for in
5		accordance with applicable law, including, but not limited to,
6		the Financial Management Act of 1979. The allottee of the
7		funds appropriated under subsections (1) $\mbox{\em and}$ (3) $\mbox{\em and}$ (4) of
8		section 1 of this act shall be the National Planner of the
9		Office of Planning and Statistics of the Federated States of
10		Micronesia, or his designee. The allottee of the funds
11		appropriated under subsection (4) of section 1 of this act
12		shall be the Lower Mortlocks Development Authority. The
13		allottee of the funds appropriated by subsection (2) of section
14		1 of this act shall be the Southern Namoneas Authority. The
15		allottee of the funds appropriated by subsection (5)(a) of
16		section 1 of this act shall be the Hall Islands Development
17		Authority. The allottee of the funds appropriated by
18		subsection (6) of section 1 of this act shall be the Executive
19		Director of the Chuuk Organization for Community Action. The
20		allottee of the funds appropriated by subsection (7) of section
21		1 of this act shall be the Governor of Chuuk State. The
22		allottee of the funds appropriated under subsection (8) of
23		section 1 of this act shall be the Speaker of the Congress of
24		the Federated States of Micronesia. The allottee of the funds
25		appropriated by sections 2, 4 and 5 of this act shall be the

1	President of the Federated States of Micronesia, or the
2	President's designee. The allottee of the funds appropriated
3	under section 3 of this act shall be the Governor of the State
4	of Yap. The allottees shall be responsible for ensuring that
5	these funds or so much thereof as may be necessary, are used
6	solely for the purposes specified in this act, and that no
7	obligations are incurred in excess of the sum appropriated.
8	The authority of the allottees to obligate funds appropriated
9	by this act shall not lapse."
10	Section 2. This act shall become law upon approval by the President
11	of the Federated States of Micronesia or upon its becoming law without
12	such approval.
