## A BILL FOR AN ACT

To further amend title 55 of the Code of the Federated States of Micronesia, as amended, by adding a new section 213 to create within the National Treasury of the Federated States of Micronesia a Capital Improvement Local Revenue Fund, to renumber the subsequent sections of Chapter 2, and for other purposes.

## BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Title 55 of the Code of the Federated States of Micronesia is
2	hereby further amended by adding a new section 213 to read as follows:
3	"Section 213. Capital Improvement Local Revenue Fund.
4	(1) There is created within the National Treasury of the
5	Federated States of Micronesia, a Capital Improvement Local
6	Revenue Fund.
7	(2) The treasurer of the Federated States of Micronesia
8	shall deposit into the Capital Improvement Local Revenue Fund all
9	funds designated therefor pursuant to section 805(2) of title 54 of
10	the Code of the Federated States of Micronesia.
11	(3) All funds deposited in the Capital Improvement Local
12	Revenue Fund shall be used for the development of the basic
13	infrastructure of the Federated States of Micronesia in
14	conformance with the intent of the Capital Improvement Program.
15	(4) Deposits to the Capital Improvement Local Revenue Fund
16	shall be made available to and administered by the President of the
17	Federated States of Micronesia or his designee. The funds shall be
18	allocated among the States in the proportion to which the funds
19	are attributable to taxes collected in each State. The President
20	shall be the allottee of the funds and shall have the authority to
21	make suballotments to the Governors of the States at such times
22	and in such manner as may be required by sound financial
23	management techniques. All funds which have been allotted to the
24	President or suballotted to the Governors of the States shall be
25	administered, managed and accounted for in accordance with

applicable law, including, but not limited to, the provisions of this chapter, and regulations pursuant thereto." Section 2. Sections 213, 214, 215, 216, 217, 218, 219, 220, 221, 222, 223, 223A, 223B, 223C, 224, 225, 226 and 227 of title 55 of the Code of the Federated States of Micronesia are hereby renumbered as sections 214, 215, 216, 217, 218, 219, 220, 221, 222, 223, 224, 225, 226, 227, 228, 229, 230 and 231 respectively. Section 3. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval. Introduced by: Jack Fritz Date: 5/31/95
