A BILL FOR AN ACT

To further amend title 40 of the Code of the Federated States of Micronesia, as amended by Public Laws Nos. 6-30, 6-44, 6-45, 8-21 and 8-132, by adding a new subchapter IV of chapter 3 for the purpose of creating a Scholarship Revolving Fund, and for other purposes.

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. Title 40 of the Code of the Federated States of
2	Micronesia is hereby further amended by adding a new section 335 of
3	subchapter IV of chapter 3 to read as follows:
4	"Section 335. Scholarship Revolving Fund. There is hereby
5	established a Scholarship Revolving Fund separate from the
6	General Fund, the Student Loan Revolving Fund, or other
7	funds. The Scholarship Revolving Fund shall be funded
8	initially by an appropriation made during the First Regular
9	Session of the Ninth Congress, in a sum equal to the total
10	funds available or expected to be available for scholarships
11	under the provisions of section 216(a)(3) of the Compact of
12	Free Association for the 1986 fiscal year."
13	Section 2. Title 40 of the Code of the Federated States of
14	Micronesia is hereby further amended by adding a new section 336 of
15	subchapter IV of chapter 3 to read as follows:
16	"Section 336. Disbursement of scholarships from Scholarship
17	Revolving Fund. The President is hereby authorized to allot
18	and expend the funds appropriated to create the Scholarship
19	Revolving Fund, and thereafter, those funds available under
20	Compact section 216(a)(3) used to replenish the Scholarship
21	Revolving Fund under section 337 of this chapter, so as to
22	ensure that money is available for the timely registration
23	and enrollment of any eligible student whose institution of
24	higher education requires such funds prior to the beginning
25	of the fiscal year.

1	(a) The Secretary of the Department of Education of
2	the Federated States of Micronesia shall be the allottee of
3	all funds to be expended from the Scholarship Revolving Fund,
4	and shall be responsible for awarding the scholarships
5	therefrom and overseeing the disbursement of such scholarship
6	funds directly to the appropriate institution of higher
7	education.
8	(b) The Secretary of the Department of Finance of the
9	Federated States of Micronesia shall be responsible for
10	managing and investing the funds in the Scholarship Revolving
11	Fund, and for ensuring that authorized expenditures are
12	disbursed promptly to the appropriate institution of higher
13	education as designated by the Secretary of Education."
14	Section 3. Title 40 of the Code of the Federated States of
15	Micronesia is hereby further amended by adding a new section 337 of
16	subchapter IV of chapter 3 to read as follows:
17	"Section 337. Reimbursement of Scholarship Revolving Fund.
18	All funds received by the Federated States of Micronesia
19	under Compact section 216(a)(3) following the creation hereby
20	of the Scholarship Revolving Fund shall upon receipt be
21	deposited in said fund for disbursement according to the
22	provisions of section 336 of this chapter."
