3	Micronesia for the fiscal year ending September 30, 1995, for the purpose of
4	providing supplemental funding for the Farmers Home Administration office in
5	the State of Kosrae.
6	Section 2. All funds appropriated by this act shall be allotted,
7	managed, administered, and accounted for in accordance with applicable law,
8	including, but not limited to, the Financial Management Act of 1979. The
9	allottee of the funds appropriated under this act shall be the President of
10	the Federated States of Micronesia or the President's designee. The
11	allottee shall be responsible for ensuring that these funds, or so much
12	thereof as may be necessary, are used solely for the purposes specified in
13	this act, and that no obligations are incurred in excess of the sum
14	appropriated. The authority of the allottee to obligate funds appropriated
15	by this act shall lapse on September 30, 1996.
16	Section 3. This act shall become law upon approval by the President of
17	the Federated States of Micronesia or upon its becoming law without such
18	approval.
