A BILL FOR AN ACT

To appropriate the sum of \$35,725 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1997, for the purpose of providing funds for repairs to low income, owner-occupied, single family homes in the State of Yap, through the Rural Economic and Development Services, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$35,725, or so much thereof as may be
- necessary, is hereby appropriated from the General Fund of the 2
- 3 Federated States of Micronesia for the fiscal year ending
- September 30, 1997, for the purpose of providing funds for 4
- repairs to low income, owner-occupied, single family homes in 5
- the State of Yap, through the Rural Economic and Community 6
- Development Services. 7
- Section 2. All funds appropriated by this act shall be
- allotted, managed, administered, and accounted for in accordance 9
- with applicable law, including, but not limited to, the 10
- Financial Management Act of 1979, as amended. The allottee 11
- shall be responsible for ensuring that these funds, or so much 12
- thereof as may be necessary, are used solely for the purpose 13
- specified in this act, and that no obligations are incurred in 14
- excess of the sum appropriated. The authority of the allottee 15
- to obligate funds appropriated by this act shall lapse as of 16
- September 30, 1997. 17
- Section 3. This act shall become law upon approval by the 18
- President of the Federated States of Micronesia or upon its 19
- becoming law without such approval. 20
