BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- Section 1. The sum of \$1,500,000, or so much thereof as may be
- 2 necessary, is hereby appropriated from the General Fund of the Federated
- 3 States of Micronesia for the fiscal year ending September 30, 1996, for the
- 4 purpose of purchasing four emergency crash, fire and rescue vehicles, to be
- 5 stationed at the four international airports in the Federated States of
- 6 Micronesia, one of which is located in each of the States of Chuuk, Kosrae,
- 7 Pohnpei and Yap.
- 8 Section 2. All funds appropriated by this act shall be allotted,
- 9 managed, administered, and accounted for in accordance with applicable law,
- 10 including, but not limited to, the Financial Management Act of 1979. The
- 11 allottee of the funds appropriated by this act shall be the President of the
- 12 Federated States of Micronesia or the President's designee. The allottee
- 13 shall be responsible for ensuring that these funds, or so much thereof as
- 14 may be necessary, are used solely for the purpose specified in this act, and
- 15 that no obligations are incurred in excess of the sum appropriated. The
- 16 authority of the allottee to obligate funds appropriated by this act shall
- 17 not lapse.
- 18 Section 3. This act shall become law upon approval by the
- 19 President of the Federated States of Micronesia or upon its becoming
- 20 law without such approval.
