A BILL FOR AN ACT

To amend Public Law No. 9-096 by amending section 14 to exempt certain positions from the employment ceilings, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 14 of Public Law No. 9-096 is hereby
