A BILL FOR AN ACT

To further amend Public Law No. 9-052, as amended by Public Laws Nos. 9-071, 9-086, 9-094, 9-108 and 9-117, by further amending section 2 at subsection (1), as amended by Public Law No. 9-094 and 9-117, to modify the use of certain funds appropriated therein for Pohnpei State, Election District No: 1, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 9-052, as amended by Public Law
2 No. 9-094, and 9-117, is hereby further amended to read as follows:

3 "Section 2. The sum of \$2,200,000, or so much thereof as may be
4 necessary, is hereby appropriated from the General Fund of the Federated
5 States of Micronesia for the fiscal year ending September 30, 1996, for the
6 purpose of funding infrastructure needs, transportation systems, and other
7 economic and social projects, public projects and for other purposes in
8 Pohnpei State. The funds appropriated under this section shall be
9 apportioned as follows:


