AN ACT

To further amend Public Law No. 8-96, as amended by Public Laws Nos. 8-130, 8-131, 8-151, 9-005 and 9-007, by further amending section 2, as amended by Public Laws Nos. 8-130, 8-151 and 9-005 to appropriate the sum of \$76,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, as supplemental funding for the operations of the legislative branch, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 8-96, as amended by Public Laws Nos.
2 8-130, 8-151 and 9-005, is hereby further amended to read as follows:

3 "Section 2. Operating expenses of the legislative branch. The sum of
4 \$3,363,927, or so much thereof as may be necessary, is hereby
5 appropriated from the General Fund of the Federated States of
6 Micronesia for the fiscal year ending September 30, 1995, for the
7 operations of the legislative branch of the National Government of the
8 Federated States of Micronesia during fiscal year 1995. The sum
9 appropriated by this section shall be apportioned as follows:

A BILL FOR AN ACT

To further amend Public Law No. 8-96, as amended by Public Laws Nos. 8-130, 8-131, 8-151, 9-005 and 9-007, by further amending section 2, as amended by Public Laws Nos. 8-130, 8-151 and 9-005 to appropriate the sum of \$39,700 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, as supplemental funding for the operations of the legislative branch, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 8-96, as amended by Public Laws
2 Nos. 8-130, 8-151 and 9-005, is hereby further amended to read as follows:

3 "Section 2. Operating expenses of the legislative branch. The sum
4 of ~~\$3,287,927~~ 3,327,627, or so much thereof as may be necessary,
5 is hereby appropriated from the General Fund of the Federated
6 States of Micronesia for the fiscal year ending September 30, 1995,
7 for the operations of the legislative branch of the National
8 Government of the Federated States of Micronesia during fiscal year
9 1995. The sum appropriated by this section shall be apportioned as
10 follows:
