A BILL FOR AN ACT

To amend Public Law No. 9-30 by amending section 5 for the purpose of appropriating \$16,800 to fund salaries and benefits for a Financial Analyst position, \$13,500 for an office automobile, \$3,000 to purchase a portable computer, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 9-30 is hereby amended to read
2 as follows:

3 "Section 5. Operating expenses of agencies of the National
4 Government. The sum of ~~\$1,882,920~~ 1,916,220, or so much thereof
5 as may be necessary, is hereby appropriated from the General Fund of
6 the Federated States of Micronesia for the fiscal year ending
7 September 30, 1996, for the operations of independent agencies,
8 commissions, authorities, boards, bureaus, and other
9 organizations of the National Government of the Federated States
10 of Micronesia during fiscal year 1996. The sum appropriated by this
11 section shall be apportioned as follows:
