A BILL FOR AN ACT

To appropriate the sum of \$35,725 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1997, for the purpose of providing funds for repairs to low income, owner-occupied, single family homes in the State of Yap, through the Rural Economic and Development Services, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$35,725, or so much thereof as may be  
2 necessary, is hereby appropriated from the General Fund of the  
3 Federated States of Micronesia for the fiscal year ending  
4 September 30, 1997, for the purpose of providing funds for  
5 repairs to low income, owner-occupied, single family homes in  
6 the State of Yap, through the Rural Economic and Community  
7 Development Services.

8 Section 2. All funds appropriated by this act shall be  
9 allotted, managed, administered, and accounted for in accordance  
10 with applicable law, including, but not limited to, the  
11 Financial Management Act of 1979, as amended. The allottee  
12 shall be responsible for ensuring that these funds, or so much  
13 thereof as may be necessary, are used solely for the purpose  
14 specified in this act, and that no obligations are incurred in  
15 excess of the sum appropriated. The authority of the allottee  
16 to obligate funds appropriated by this act shall lapse as of  
17 September 30, 1997.

18 Section 3. This act shall become law upon approval by the  
19 President of the Federated States of Micronesia or upon its  
20 becoming law without such approval.

A BILL FOR AN ACT

To appropriate the sum of \$17,123 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1996, for the purpose of reappropriating certain funds which lapsed September 30, 1994, under Public Law No 7-96, as amended, for the purpose of funding the construction of a school in Kolonia Town in the State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$17,123, or so much thereof as may be necessary, is  
2 hereby appropriated from the General Fund of the Federated States of Micronesia  
3 for the fiscal year ending September 30, 1996, for the purpose of funding the  
4 construction of a school in Kolonia Town in the State of Pohnpei.

5 Section 2. All funds appropriated by this act shall be allotted, managed,  
6 administered, and accounted for in accordance with applicable law,  
7 including, but not limited to, the Financial Management Act of 1979. The  
8 allottee of the funds appropriated hereunder shall be the Mayor of Kolonia  
9 Town. The allottee shall be responsible for ensuring that these funds, or so  
10 much thereof as may be necessary, are used solely for the purpose specified  
11 in this act, and that no obligations are incurred in excess of the sum  
12 appropriated.

13 Section 3. This act shall become law upon approval by the President of  
14 the Federated States of Micronesia or upon its becoming law without such  
15 approval.
