A BILL FOR AN ACT

To further amend Public Law No. 8-75, as amended, by further amending section 3, as amended by Public Laws Nos. 8-79, 8-116, 8-145, 8-149, 9-004 and 9-013, for the purpose of changing an allottee of funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 8-75, as amended by Public Laws Nos.
2 8-79, 8-116, 8-145, 8-149 9-004 and 9-013, is hereby further amended to read as
3 follows:


4 "Section 3. All funds appropriated by this act shall be allotted, managed,
5 administered, and accounted for in accordance with applicable law, including,
6 but not limited to, the Financial Management Act of 1979. The allottee of the
7 funds appropriated under subsection (1)(a) of section 2 of this act shall be
8 the PWP Development Authority, except that the allottee of the funds
9 appropriated under subsection (1)(a)(iv)c) of section 2 shall be the Tolesom
10 Economic Authority. The allottee of the funds appropriated under subsections
11 (1)(b)(i), (1)(b)(ii), (1)(b)(iii) and (1)(b)(iv) of section 2 of this act
12 shall be the Mayor of Fono. The allottee of the funds appropriated under
13 subsections (1)(b)(v), (1)(b)(vi) and (1)(b)(vii) of section 2 of this act
14 shall be the Mayor of Pis-Paneu. The allottee of the funds appropriated under
15 subsections (1)(b)(viii), (1)(b)(x), (1)(b)(xi), and (1)(b)(xvii) of
16 section 2 of this act shall be the Mayor of Weno. The allottee of funds
17 appropriated under subsections (1)(b)(ix), (1)(b)(xii), (1)(b)(xiii),
18 (1)(b)(xiv), (1)(b)(xv), (1)(b)(xvi), and (1)(b)(xviii) of section 2 of
19 this act shall be the Weno Projects Coordinator. The allottee of the funds
20 appropriated under subsection (1)(c) of section 2 of this act shall be the
21 Southern Namoneas Development Authority. The allottee of the funds
22 appropriated under subsection (1)(d) of section 2 of this act shall be the
23 Lower Mortlocks Development Authority. The allottee of the funds
24 appropriated under subsection (1)(e)(i) and (1)(e)(ii) of section 2 of this
25 act shall be the Executive Director of the Hall Development Authority. The

1 allottee of the funds appropriated under subsection (1)(e)(iii) of section 2 of
2 this act shall be the Pattiw Development Authority. The allottee of the funds
3 appropriated under subsections (1)(e)(iv), (1)(e)(v) and (1)(e)(vi) of
4 section 2 of this act shall be the Weito Development Authority. The allottee of
5 the funds appropriated under subsections (1)(e)(vii), (1)(e)(viii),
6 (1)(e)(ix), (1)(e)(x), (1)(e)(xi)a, (1)(e)(xii), and (1)(e)(xiii) of
7 section 2 of this act shall be the Pattiw Development Authority. The allottee of
8 the funds appropriated under subsections (1)(e)(xi)b) of section 2 of this act
9 shall be the Director of Public Safety for the State of Chuuk. The allottee of
10 the funds appropriated under subsections (1)(e)(xi)c) of section 2 of this act
11 shall be the Director of the Chuuk State Department of Agriculture. The
12 allottee of the funds appropriated under subsections (1)(f)(i), (1)(f)(ii)
13 and (1)(f)(vi) of section 2 of this act shall be the Executive Director of COCA.
14 The allottee of the funds appropriated under subsection (1)(f)(iii),
15 (1)(f)(iv) and (1)(f)(v) of section 2 of this act shall be the Governor of the
16 State of Chuuk. The allottee of the funds appropriated under subsection
17 (1)(f)(vii) of section 2 of this act shall be the Lower Mortlocks Development
18 Authority. The allottee of the funds appropriated under subsection (2)(a)(i)
19 of section 2 of this act shall be the Luhkenkolwof of Sapwuaifik. The allottee of
20 the funds appropriated under subsection (2)(a)(ii) of section 2 of this act
21 shall be the Chief Magistrate of Nukuoro. The allottee of the funds
22 appropriated under subsection (2)(a)(iii) of section 2 of this act shall be the
23 Chief Magistrate of Kapingamarangi. The allottee of the funds appropriated
24 under subsection (2)(a)(iv) of section 2 of this act shall be the Mayor of
25 Kolonia Town. The allottee of the funds appropriated under subsections

1 (2)(a)(v)a, (2)(a)(v)b, ~~(2)(a)(v)f~~ and 2(a)(v)i) of section 2 of this
2 act shall be the Chief Magistrate of Sokehs. The allottee of the funds
3 appropriated under subsections (2)(b), (2)(c), (2)(e), (2)(f), (4)(b),
4 (4)(c), (4)(d), (4)(e), (4)(f), (4)(g), (4)(h), (4)(i), (4)(j) and
5 (4)(k) of section 2 of this act shall be the President of the Federated States of
6 Micronesia. The allottee of the funds appropriated under subsections
7 (2)(a)(v)c) of section 2 of this act shall be the Pohnpei Utility Corporation.
8 The allottee of funds appropriated under subsection (2)(d) of section 2 of this
9 act shall be the Pohnpei Transportation Authority. The allottee of the funds
10 appropriated under subsection 3 of section 2 of this act shall be the Governor
11 of the State of Yap or his designee. The allottee of the funds appropriated under
12 subsection (4)(a) of section 2 of this act shall be the Chairman of the Kosrae
13 Sports Council. The allottee of the funds appropriated under subsections
14 (4)(l) and (4)(n) of section 2 of this act shall be the Mayor of the Lelu
15 Municipal Government. The allottee of the funds appropriated under
16 subsections (4)(m) and (4)(o) of section 2 of this act shall be the Mayor of
17 the Malem Municipal Government. The allottee of the funds appropriated
18 under subsection (4)(p) of section 2 of this act shall be the President of the
19 Federated States of Micronesia. The allottee of the funds appropriated under
20 subsection (4)(q) of section 2 of this act shall be the Mayor of the Tafunsak
21 Municipal Government. The allottees shall be responsible for ensuring that
22 these funds, or so much thereof as may be necessary, are used solely for the
23 purposes specified in this act, and that no obligations are incurred in excess of
24 the sum appropriated. The authority of the allottees to obligate funds
25 appropriated by this act shall not lapse."

1 Section 3. This act shall become law upon approval by the President of the Federated
2 States of Micronesia or upon its becoming law without such approval.
